CSO President Report: Greg Adams thanked the CSO for participating in EARTH DAY activities. He reports that he is contacting reporters to see about an article featuring Anastasia State Park.

# 5.1 Managers Report: Warren Poplin

The 70<sup>th</sup> Anniversary of the end of WW II is this year and state parks have been encouraged to recognize this. Our park may consider a banner to thank our veterans and honor this special year.

Warren will speak about the park at the Chamber of Commerce meeting this month. (Some important facts to be shared: Over 41 million dollars are contributed yearly to the economy and 575 jobs are supported)

The park has a call for business plan out for the operations of the concession. The current contract finishes in September. Cape Leisure will submit a bid.

The UMP is in the review process now. This will eventually have a public meeting for input from local citizens.

- 1) Camping: plans are to expand 30-60 sites. This may include a "pull thru site", 50 AMP electric and septic tie in.
- 2) Beach access points may increase including boardwalks
- 3) Increase access to the fishing area may include an ADA access

Playgrounds are now out for bids, this is handled by our bureau of design and construction.

The sunshade structure is due to be delivered with a ship date of 4/24/15. A check for \$8146.00 is due. An additional \$600.00 for the cost of the drawings is also due. (NOTE: A motion was made to add the money needed from the miscellaneous account to the playground for the drawings by Sharon and seconded by Karl and was approved by all).

The October 2016 State Parks Directors meeting (about 75 people attend) will be held in St. Augustine and some of the activities will take place at our park.

One of the golf cart engines is currently being repaired with a cost of \$900. An additional golf cart would benefit the park and a rebuilt one would cost about \$2800. A discussion followed and members agreed to consider a purchase in the future, perhaps exploring a grant for this.
