Karl presented the idea the that Ancient City Road Runners were interested in running through the park during daily runs and would make a lump sum donation in lieu of paying individual entrance fees in order to do this. Warren reported that this wasn't something that would be allowed unless the individual had paid the applicable entrance fees as mandated by state legislature.

The board viewed images of the mouse for the new logo. Triss made a motion that we accept a particular one and Rich seconded it. The group agreed. The name change is still being worked on and Greg reported that the DBA process is still the best way to go. He will talk further with Alex about this.

Greg would like us to join Friends of Florida State Parks which supports all CSOs in the state. The cost is \$100.00. He suggested we each look at the web site and we will vote on at the next meeting.

Greg provided us with the handout "Model CSO: Productive and Rewarding Partnerships" in order to glean the working relationships that can result when CSOs align with the Park staff.

Greg also encouraged us to think about developing a plan for fundraising that would be a "Case for Support". This would include a Power Point Show that presented the CSO's fund raising results and purchases. An Advisory Board to help with Fund Raising efforts is also a consideration.

There was also a discussion on developing a new mission statement for the group. Greg presented the Friends of McArthur State Park's mission statement. There were pieces that the group liked, but all agreed it needed to be worked on more. Warren quoted the park's mission statement and said the Friends mission statement should be closely in line with the park's mission statement. All agreed and said once edited, the new mission statement would be put to a vote.
